Re: Questions re Special Meeting to Declare an ANC Vacancy

Commissioner Cockrell:

Your ANC's Chairperson sent ANC 4B05 Commissioner Yolanda Hughes a letter alleging that she "do[es] not now and ha[s] not resided continuously within the boundaries of [her] single member district," and informing her that he has called a special meeting to "to declare the ANC 4B05 seat on the Commission vacant." You asked us, on an expedited basis, two questions about this meeting.

First, you asked whether calling such a meeting is consistent with the ANC statute. It depends on what the Chairperson's letter meant by "declare the ANC 4B05 seat on the Commission vacant." When a Commissioner ceases to reside in his or her single-member district, the ANC does not have the power to declare the seat vacant on its own. But the ANC can, and must, petition the Board of Elections to declare the seat vacant. Accordingly, if the purpose of this special meeting is simply to vote on whether the ANC should submit such a petition, based on the ANC's conclusions about whether Commissioner Hughes resides in her single-member district, the meeting is consistent with the ANC statute. If, however, the purpose of the meeting is to vote on whether the ANC itself should declare the seat vacant, the meeting is improper.

When a vacancy occurs in an Advisory Neighborhood Commission and no letter of resignation is submitted as required by paragraph (1) of this subsection, the respective Advisory Neighborhood Commission shall petition the Board, by a resolution signed by the Chairperson and the secretary of the Advisory Neighborhood Commission, to declare the vacancy. The resolution shall be considered by the Advisory Neighborhood Commission at a special Advisory Neighborhood Commission meeting called for the purpose of considering the vacancy.

Second, you asked whether Commissioners, including the Commissioner whose seat is at issue, must attend and participate in the meeting. Nothing in the ANC statute requires them to do so, so unless your ANC's Bylaws require them to attend and participate, each Commissioner has the freedom to decide whether he or she will do so.
