Dear Mr. Coleman:

The Office of the Attorney General for the District of Columbia (OAG) has learned that there have been several rental properties advertised on Apartments.com in the District that state that the poster does not accept rental payments through Section 8 or housing choice vouchers. Attached are a few of the advertisements that have been brought to our attention.

The District of Columbia Human Rights Act prohibits discrimination in housing based on an individual's source of income, including the use of Section 8 vouchers. D.C. Official Code § 2-1402.21(a), (e). Refusing to accept Section 8 vouchers as a rental payment is a facial violation of the statute, as is posting an advertisement stating that a landlord does not accept vouchers.

Ensuring that voucher recipients have access to high-quality housing throughout the District is a significant priority for OAG. We would thus like to set up a call or meeting to discuss how CoStar Group, Inc. can help ensure that advertisements that violate the prohibition on source-of-income discrimination either do not appear on your platforms or are quickly removed.
